RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of August 16, 2021 (the “Effective Date”), is made by CORTLAND CAPITAL MARKET SERVICES LLC, in its capacity as collateral agent for the secured parties (the “Collateral Agent”), in favor of, YOUVISIT LLC (the “Pledgor”).

WHEREAS, pursuant to that certain Second Lien Security Agreement, dated as of November 17, 2017, by and among EAB Global, Inc., a Delaware Corporation, Avatar Holdco LLC, as a pledgor thereto and the other pledgors undersigned thereto, the Collateral Agent and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Pledgor granted to the Collateral Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral, including, without limitation, the trademark registrations and applications set forth Schedule 1 attached hereto, arising under the Security Agreement (as defined below) and the Trademark Security Agreement (as defined below) (the “Trademarks”), which Trademarks are pending or registered with the United States Patent and Trademark Office;

WHEREAS, pursuant to the Security Agreement, YouVisit LLC executed and delivered a Second Lien Trademark Security Agreement, amongst YouVisit LLC and the Collateral Agent, dated as of February 5, 2020 (the “Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 6, 2020 at Reel/Frame No. 006858/0491;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:


1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.
2. Release. As relates to the Pledgor, the Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including, without limitation the Trademarks set forth in Schedule 1 attached hereto. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Pledgor.
3. Termination. The Collateral Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.
4. Further Assurances. The Collateral Agent agrees to take all further actions, and provide to the Pledgor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgor, at the Pledgor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.


