DECLARATION REGARDING OWNERSHIP

I, Ted Hagman declares as follows:

1. I am a trademark attorney with Awa Sweden AB and a legal representative for Pyrotek Scandinavia AB, an aktiebolag of Sweden, in connection with various trademark matters, including the maintenance of U.S. Registration No. 3,889,143 for the mark CERAFORTE (the "CERAFORTE Registration") issued December 14, 2010.

2. The CERAFORTE Registration issued to Elkem AS, a corporation of Norway.

3. On April 13, 2015 an assignment of the CERAFORTE Registration executed September 17, 2014 from Elkem AS, a limited liability company of Norway, to Pyrotek Scandinavia AB, a limited liability company of Sweden, was recorded.

4. On November 17, 2020, a Combined Declaration of Use and Application for Renewal was filed for the CERAFORTE Registration in the name of Pyrotek Scandinavia AB, a limited liability company of Sweden.

5. In fact, Elkem AS was an aksjeselskap organized under the laws of

Norway.

6. I have reviewed the Norwegian corporate register and determined that there was no entity "Elkem AS, a corporation of Norway" nor was there an "Elkem AS, a limited liability company of Norway" registered during the relevant period.

7. It is clear to me that the Elkem AS entity referred to by the CERAFORTE Registration and assignment executed September 17, 2014 is Elkem AS, an aksjeselskap of Norway.


8. Pyrotek Scandinavia AB was and is an aktiebolag organized under the laws of Sweden. The mistakes in the manner in which Pyrotek Scandinavia AB was identified were made in good faith and with no intent to deceive.

9. I have reviewed the Swedish corporate register and determined that there was no entity "Pyrotek Scandinavia AB, a limited liability company of Sweden" registered during the relevant period.

10. It is clear to me that the Pyrotek Scandinavia AB referred to by the assignment executed September 17, 2014 and the Combined Declaration of Use and Application for Renewal filed November 17, 2020 is Pyrotek Scandinavia AB, an aktiebolag of Sweden, and that these errors were made in good faith and with no intent to deceive.

The undersigned being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements and the like may jeopardize the validity of this submission, declares that all statements made of his/her own knowledge are true; and all statements made on information and belief are believed to be true.
