## TRADEMARK ASSIGNMENT

**This Trademark Assignment** (“Assignment”) is made by and between **GRAND-AIDES INTERNATIONAL, INC.**, a Nevis corporation (“ASSIGNOR”), and **GRAND AIDES USA, INC.**, a Texas corporation (“ASSIGNEE”).

**WHEREAS**, ASSIGNOR, through assignment, is the owner of all right, title and interest in trademark registration number 4,018,409 for GRAND-AIDES (the “Mark”), which registered with the United States Patent & Trademark Office on August 30, 2011 (the “Registration”); and

**WHEREAS**, ASSIGNEE has been using the Mark for healthcare services with the permission of ASSIGNOR; and

**WHEREAS**, ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its right, title, and interest in and to the Registration, and any and all rights to the Mark in the United States and throughout the world and all good-will associated with the Registration and the Mark throughout the world; and

**WHEREAS**, ASSIGNEE desires to acquire all of ASSIGNOR’S worldwide right, title and interest in and to the Registration and the Mark including all good-will associated therewith;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR’S right, title, and interest throughout the world of whatever kind in any jurisdiction in and to the Registration and the Mark, together with (1) the goodwill of the business relating to the goods with which the Mark is used and for which it is registered; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Mark, including without limitation, damages, and payments for past or future infringements and misappropriations of the Mark or the Registration; and (3) all rights to sue for past, present and future infringements or misappropriations of the Mark or the Registration, the same to be held and enjoyed by ASSIGNEE as fully and entirely as said interest could have been held and enjoyed by ASSIGNOR had this sale, assignment, transfer and conveyance not been made.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Mark and the Registration.

ASSIGNOR authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the Registration to ASSIGNEE as assignee of ASSIGNOR’S entire right, title and interest therein. ASSIGNOR agrees to further execute any documents reasonably necessary to effect this assignment or to confirm ASSIGNEE’s ownership of the Mark.

This Assignment may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument.
