TERMINATION AND RELEASE OF SECURITY INTEREST

This **TERMINATION AND RELEASE OF SECURITY INTEREST**, dated as of August 26, 2021 (this "Release"), is made by **FIFTH THIRD BANK, NATIONAL ASSOCIATION**, a national banking association of the United States ("Secured Party"), in favor of **ROUND 2, LLC, AUTOWORLD.COM LLC, and ROUND 2 HOLDINGS, LLC**, all of which are Indiana limited liability companies ("Debtors").

WHEREAS, pursuant to that certain (a) Credit and Security Agreement dated as of January 12, 2021 ("Credit Agreement") by and among the Debtors and Secured Party, and (b) that certain Intellectual Property Security Agreement dated as of January 12, 2021, executed and delivered by Debtors to Secured Party (the "IP Security Agreement"), Debtors granted to the Secured Party a continuing security interest in various assets, including the trademark listed on Schedule A attached hereto (such trademark is the "Brick Racers Trademark");

WHEREAS, the IP Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on January 26, 2021 at Reel 7170/ Frame 0253.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein, and in reliance on Debtors' representations, warranties and covenants set forth below, and with the intention of being legally bound hereby, Secured Party hereby agrees as follows:

SECTION 1. Termination and Release. Secured Party hereby:

(a) terminates its security interest in the Brick Racers Trademark and that certain License Agreement dated November 12, 2019, by and between Round 2, LLC and My World Outside LLC (the "My World License");

(b) represents and warrants that it has full authority to execute and deliver this Release; and

(c) authorizes the recordation of this Release with the USPTO at Debtors' expense.

SECTION 2. Representations, Warranties and Covenants of Debtors. Debtors hereby represent, warrant and covenant to and with Secured Party as follows: (a) the Brick Racers Trademark and My World License have de minimus value, and (b) Debtors will not manufacture, purchase or sell any products utilizing the Brick Racers Trademark or the My World License.


SECTION 3. [Reserved].
