**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”), effective as of August 18, 2021, is made by **ROYAL BANK OF CANADA**, in its capacity as collateral agent for the secured parties (in such capacity, the “Collateral Agent”), in favor of **STX MANAGEMENT SERVICES, INC.**, and **ACCESS DENTAL SERVICES, LLC** (individually, the “Pledgor”, and collectively, the “Pledgors”), as follows:

**W I T N E S S E T H**

WHEREAS, the Pledgors and the Collateral Agent are party to the Trademark Security Agreement, each dated as of February 4, 2019 (as amended, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), which was duly recorded on February 2, 2019 at Reel/Frame 6549/0500 in the United States Patent and Trademark Office, pursuant to which the Pledgors pledged and granted to the Collateral Agent, a security interest in and continuing lien on all right, title and interest of the Pledgors in and to the trademark registrations and trademark applications set forth on Schedule 1 attached hereto, including all goodwill associated therewith (collectively, the “Trademarks”); and

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Collateral Agent hereby terminates the Trademark Security Agreement and hereby terminates, cancels, discharges and releases any and all liens and security interests that the Collateral Agent has in, to and under the Trademarks.
2. Authorization to Record. The Collateral Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Release.
3. Further Assurances. The Collateral Agent hereby agrees, at Pledgors’ sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the intents and purposes of this Release.
4. Governing Law. This Release shall be governed by, and construed and enforced in accordance with, the law of the State of New York.
