AFFIDAVIT TO AFFIRM THE RELEASE OF SECURITY AGREEMENT

This Affidavit to Affirm the Release of Security Agreement is effective as of August 24, 2021 pursuant to the fulfillment of the loan obligations.

I, Kevin Rule, do hereby declare as follows:

I am the Chief Financial Officer of **CLAIRE-SPRAYWAY, INC.**, a Delaware Corporation, located at 2651 Warrenville Road Downers Grove, Illinois United States 60515, successor of **CLAIRE MANUFACTURING COMPANY** (referred hereafter as, the "Company").

1. Pursuant to that certain Trademark Security Agreement, dated as of April 4, 1995 (the "Security Agreement"), the Company granted a security interest to BANQUE PARIBAS (the "Collateral Agent") in the trademark registrations set forth on Schedule A attached hereto (the "Trademarks").
2. The Security Agreement was recorded at the U.S. Patent and Trademark Office (the "PTO") on April 25, 1995 at Reel/Frame 1338/0302 with respect to the Trademarks.
3. To the best of my knowledge, the obligations secured under the Security Agreement were satisfied. Company repaid all its outstanding loans and other obligations in full, and the Collateral Agent, on behalf of itself and the holders of the Secured parties, terminated and released its security interest in the Trademarks.
4. Due to unknown reasons, a release of the Security Agreement was not filed with the USPTO.
5. The undersigned, being hereby advised that willful false statement and the like so made are punishable by fine or imprisonment, or both, under 18 U. S. C. 1001, declares that the facts set forth in this declaration are true; all statements made of his/her own knowledge are true; and all statements made on information and belief are believed to be true.
