INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (this “Assignment Agreement”) is entered into as of August 1, 2021 (the “Effective Date”), by and between Francis Ford Coppola Presents, LLC, a Delaware limited liability company with a principal place of business of P.O. Box 208, 1991 Saint Helena Highway, Rutherford, CA 94573 (“FFCP”), GMYL, L.P., a California limited partnership with a principal place of business of 916 Kearny St., San Francisco, CA 94133 (“GMYL”), and Francis Coppola Winery, LLC, a Delaware limited liability company with a principal place of business of 300 Via Archimedes, Geyserville, CA, 95441 (“FCW” and collectively with FFCP and GMYL, “Assignor”), on the one hand, and Delicato Vineyards, LLC, a Delaware limited liability company with a principal place of business of 12001 South Highway 99, Manteca, CA 95336 (“Assignee”), on the other hand.

A. Assignor, Assignee, and certain other parties thereto have entered into that certain Business Contribution Agreement, dated as of June 23, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the “Contribution Agreement”), providing, subject to the terms and conditions set forth therein, Assignor has agreed to sell, transfer, assign, convey and deliver to Assignee, and Assignee has agreed to accept, acquire and assume, certain assets and liabilities of Assignor;

B. The execution and delivery of this Assignment Agreement is required pursuant to the closing of the transactions contemplated by the Contribution Agreement; and

C. Assignor is willing to assign to Assignee all rights it may have in and to the Business Intellectual Property Assets on the terms and subject to the conditions set forth in this Assignment Agreement.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Assignor and Assignee, Assignor and Assignee agree as follows:

1. Definitions. Unless otherwise defined herein, each capitalized term used herein shall have the meaning assigned thereto in the Contribution Agreement.

2. Assignment. Assignor hereby irrevocably sells, assigns, conveys, transfers, sets over, and delivers to Assignee, all of Assignor’s worldwide right, title and interest in and to the Business Intellectual Property Assets, including without limitation all worldwide right, title and interest in and to:

(a) the transferred trademark applications and registrations and transferred common law trademarks identified in Exhibit A (the “Transferred Trademarks”);

(b) The internet domain names identified in Exhibit A (the “Transferred Domain Names”);

(c) The social media accounts identified in Exhibit A (the “Transferred Social Media Accounts”);

(d) the Software identified in Exhibit A (a)-(d) are collectively referred to as the “Transferred Intellectual Property”);

(e) all of Assignor's right to file trademark and copyright applications (as applicable) in the United States and throughout the world for the Transferred Intellectual Property in the name of Assignee, its successors and assigns; and

(f) and all rights in any of the foregoing, including rights to sue or recover and retain damages for past, present, and future infringement, dilution, misappropriation or other violation of any of the foregoing.

3. Authorization. Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States, the Register of Copyrights of the United States, and the corresponding entities, agencies or registrars in the United States or any applicable foreign jurisdictions, whose duty is to issue trademarks and copyrights, to issue the same to Assignee and to record Assignee as owner of the Transferred Trademarks and Copyrights.

4. Further Assurances. Assignor shall provide Assignee, its successors and assigns, at Assignee's expense, with all such reasonable assistance as may be reasonably required for the full utilization of the rights granted in Section 2, above, including, without limitation, upon request by Assignee to execute (subject to Assignor's reasonable opportunity to review and comment on the applicable document or instrument) and use reasonable efforts cause its current or former employees or contractors to execute, as applicable, all applications and any further assignments or other documents or instruments, execute confirmatory assignments or notarized assignments necessary to record or effectuate assignments in certain jurisdictions, sign all lawful papers, and make all rightful oaths necessary to carry out the purposes or intent of this Assignment Agreement and to record Assignee as owner of the Transferred Intellectual Property. Without limiting the foregoing, Assignor will do all things that are reasonably necessary to assist Assignee in transferring all domain names that are Transferred Intellectual Property, including as applicable, placing each of the domain names in "unlocked" status and provide Assignee the Internet domain name registrars' transfer authorization codes for each of the domain names and any other information required to effectuate the transfer of Assignor's right, title and interest in the domain names to Assignee. Assignor shall not assert any ownership right, title or interest in or to any of the Transferred Intellectual Property and shall not use any of the Transferred Intellectual Property except to the extent permitted under any of the Transaction Documents.

5. Interpretation. For purposes of this Assignment Agreement, (a) the words "include," "includes" and "including" shall be deemed to be followed by the words "without limitation" and (b) the words "herein," "hereof," "hereby," "hereto" and "hereunder" refer to this Assignment Agreement as a whole. Unless the context otherwise requires, references herein: (x) to Sections and Exhibits mean the Sections of, and Exhibits attached to, this Assignment Agreement; (y) to an agreement, instrument or other document means such agreement, instrument or other document as amended, supplemented and modified from time to time to the extent permitted by the provisions thereof and (z) to a statute means such statute as amended from time to time and includes any successor legislation thereto and any regulations promulgated thereunder. This Assignment Agreement shall be construed without regard to any presumption or rule requiring construction or interpretation against the party drafting an instrument or causing any instrument to be drafted. The Exhibits referred to herein shall be construed with, and as an integral part of, this Assignment Agreement to the same extent as if they were set forth verbatim herein.

6. Governing Law. This Assignment Agreement shall be governed by and construed in accordance with the domestic Laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of the Laws of any jurisdiction other than the State of Delaware.

7. Counterparts. This Assignment Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment Agreement delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment Agreement.

8. No Waiver. No waiver by any party of any of the provisions hereof shall be effective unless explicitly set forth in writing and signed by the party so waiving. No waiver by any party shall operate or be construed as a waiver in respect of any failure, breach or default not expressly identified by such written waiver, whether of a similar or different character, and whether occurring before or after that waiver. No failure to exercise, or delay in exercising, any right, remedy, power or privilege arising from this Assignment Agreement shall operate or be construed as a waiver thereof; nor shall any single or partial exercise of any right, remedy, power or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power or privilege.

9. Binding Agreement; No Third Party Beneficiaries. This Assignment Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and permitted assigns. No party may assign its rights or obligations hereunder without the prior written consent of the other parties, which consent shall not be unreasonably withheld, conditioned or delayed. No assignment shall relieve the assigning party of any of its obligations hereunder. This Assignment Agreement is for the sole benefit of the parties hereto and their respective successors and permitted assigns and nothing herein, express or implied, is intended to or shall confer upon any other Person or entity any legal or equitable right, benefit or remedy of any nature whatsoever under or by reason of this Assignment Agreement.

10. Entire Agreement; Amendment. This Assignment Agreement and the Contribution Agreement and any other IP-related Transaction Documents represent the entire agreement between the parties with respect to the assignment of the Transferred Intellectual Property by Assignor to Assignee and may be modified or amended only by a writing signed by all parties hereto that specifically mentions this Assignment Agreement. The parties acknowledge and agree that the representations, warranties, covenants and agreements contained in the Contribution Agreement and Trademark Co-Existence Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Contribution Agreement or Trademark Co-Existence Agreement and the terms hereof, the terms of the Contribution Agreement and Trademark Co-Existence Agreement shall govern. Without limiting the generality of the foregoing, nothing contained in this Assignment Agreement shall be deemed to expand the definition of the Contributed Assets set forth in the Contribution Agreement.
