TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“Trademark Assignment”) is made and entered into this 29 day of August 2021 (the “Effective Date”), by and between Farmland West, Inc. (“Assignor”) and Cultivate Franchise Corp (“Assignee”).

WHEREAS, Assignor desires to assign of all of its right, title, and interest that it has or may have in and to certain trademarks, as described herein, to Assignee subject to the terms specified herein; and

WHEREAS, Assignee desires to obtain an assignment of all of Assignor’s right, title, and interest in and to such trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. **Assignment.** Assignor hereby irrevocably conveys, transfers, and assigns to Assignee all right, title, and interest that Assignor has or may have in and to the trademarks set forth on Exhibit 1 hereto and all issuances, extensions, and renewals thereof (the “Trademarks”), together with the goodwill of the business connected with the use of, and symbolized by, the Trademarks.
2. **Recordation and Further Actions.** Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Trademark Assignment upon request by Assignee. Following the date hereof, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Trademarks to Assignee, or any assignee or successor thereto.
3. **Enforceability and Waiver.** If any clause, sub clause or other provision of this Trademark Assignment is held to be invalid, illegal or otherwise unenforceable, the remaining provisions of this Trademark Assignment will remain in full force. Failure or neglect by a party to enforce at any time, any of the provisions of this Trademark Assignment shall not be construed nor shall be deemed to be a waiver of that party’s rights under this Trademark Assignment nor in any way affect the validity of the whole or any part of this Trademark Assignment nor prejudice that party’s rights to take subsequent action.
4. **Headings.** The headings appearing in this Trademark Assignment have been inserted for identification and reference purposes only and shall not be used in the construction and interpretation of this Trademark Assignment.
5. **Counterparts.** This Trademark Assignment may be executed in counterparts, each of which shall be an original, which together shall constitute one and the same instrument binding on the parties.
