RELEASE OF SECURITY INTEREST IN TRADEMARKS

NOW, THEREFORE, for good and valuable consideration, the receipt, sufficiency and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

Secured Party absolutely and unconditionally terminates, cancels, discharges and releases, without recourse, representation or warranty of any kind, any and all security interests he has against the Trademarks pursuant to Security Agreement or otherwise.


