TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination and Release") is granted as of August 31, 2021 by SILICON VALLEY BANK, as security agent (the "Security Agent"), in favor of AMCS GROUP, INC. (the "Grantor").

- (ii) all patents and patent applications, domestic or foreign, all licenses relating to any of the foregoing, and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof;
- (iii) all copyrights and applications for copyright, domestic or foreign, together with the underlying works of authorship (including titles), whether or not the underlying works of authorship have been published whether said copyrights are statutory or arise under the common law, and all other rights and works of authorship, all computer programs, computer databases, computer program flow diagrams, source codes, object codes and all tangible property embodying or incorporating any copyrights, all licenses relating to any of the foregoing and all rights of renewal and extension of copyright;

(together, the "Intellectual Property Collateral");

WHEREAS, the Grant was recorded with the Assignment Division of the U.S. Patent & Trademark Office ("USPTO") on November 15, 2019, at Reel 6796, Frame 0963;

WHEREAS, the Grantor has requested that Security Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Trademarks identified in Schedule I hereto as herein provided; and

WHEREAS, the Grantor has requested that the Security Agent provide a document suitable for recording with the USPTO to evidence the release of the Security Agent's security interests in and liens on the certain Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereby:

- 1. terminates the Grant and releases, terminates, cancels, reassigns, releases and discharges any and all liens and security interests, including the Intellectual Property Security Interest, it has in and against the Intellectual Property Collateral, including those listed in Schedule I hereto, and all goodwill associated therewith;
- 2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
- 3. agrees to execute and deliver to the Grantor any and all further documents and instruments, and do any and all further acts which the Grantor (or their agents or designees) reasonably request in writing (at the Grantor's sole cost and expense) in order to confirm this Termination and Release and the Grantor's right, title and interest in, to and under the Intellectual Property Collateral.
