## CONFIRMATORY INTELLECTUAL PROPERTY ASSIGNMENT

This Confirmatory Intellectual Property Assignment is entered into by and between Mybite Vitamins, LLC., a Washington limited liability company having a principal place of business located at 9604 NE 126<sup>th</sup> Avenue, Suite 2330, Vancouver, WA 98682 (“Assignor”) and Goli Nutrition Inc., a Canadian corporation with offices located at 1, Westmount Square, Suite 1500, Westmount, Quebec, H3Z 2P9, Canada (“Assignee”).

**WHEREAS**, Assignor as owner of the trademarks listed in Exhibit A (the “Intellectual Property”) has assigned the Intellectual Property to Assignee in connection with that certain Trademark Assignment dated May 6, 2021 (the “Assignment Agreement”); and

**WHEREAS**, the parties execute this Confirmatory Intellectual Property Assignment for the sole purpose of memorializing and recording the Assignment effected by the Assignment Agreement.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

**1. Assignment.** As of the effective date of the Assignment Agreement, Assignor does hereby, irrevocably assign, transfer and convey to Assignee, and Assignee does accept, all of Assignor’s right, title and interest in and to the Intellectual Property, including but not limited to any additional trademarks and any registrations, applications, renewals and parts thereof, all common law rights therein, all moral rights therein, together with the goodwill of the business symbolized by or embodied in the Intellectual Property and all claims to be made by Assignee for damages by reason of past or future infringements of the Intellectual Property by third-party entities with the right to sue for and collect the same for Assignee’s own use and benefit, and for the use and on behalf of its successors, assigns and other legal representatives. These obligations shall be binding upon Assignor’s successors, assigns, heirs, executives, administrators, and other legal representatives.

**2. Authorization and Recordation.** Assignor hereby authorizes and requests all applicable governmental authorities or registrars to record and register Assignee as the owner of the Intellectual Property, and to issue any and all registrations, amended registrations and renewals that have been or may be granted upon any application or petition for the same, to Assignee and Assignee’s successors and/or assigns, as assignee of all of Assignors’ rights, title and interest in and to the Intellectual Property. Assignee shall have the right to record this Assignment with all applicable governmental authorities and registrars so as to perfect ownership of the Intellectual Property.

**3. Miscellaneous.** Each party represents that it has the power and authority to enter into this Confirmatory Intellectual Property Assignment. If any term of this Confirmatory Intellectual Property Assignment is held invalid or unenforceable for any reason, the remainder of such term shall be amended to achieve as closely as possible the effect of the original term, and all other terms shall continue in full force and effect. This Confirmatory Intellectual Property Assignment may be executed in any number of identical counterparts, each of which shall be deemed an original, but all of which when taken together, shall constitute one and the same instrument.
