RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this "Release"), is made as of September 1, 2021 (the "Effective Date") by Bank of America, N.A. ("Bank of America"), as collateral agent for the First Lien Secured Parties under the security agreement referenced below (in such capacity, the "Collateral Agent"), with respect to the trademark CHARGE RESCUE, U.S. Registration No. 5,811,118 (the "Released Trademark").

W I T N E S S E T H :

WHEREAS, HCA-HealthONE LLC (the "Grantor") and Bank of America are parties to the First Lien Security Agreement dated as of November 17, 2006 in favor of the Collateral Agent (together with all amendments, modifications and supplements, if any, from time to time thereafter made thereto, the "First Lien Security Agreement");

WHEREAS, pursuant to the First Lien Security Agreement, Grantor granted to the Collateral Agent a security interest in the Released Trademark and recorded a Grant of Security Interest in Trademark Rights dated December 21, 2018 (the "Trademark Security Agreement"), which was recorded with the United States Patent and Trademark Office on December 21, 2018, at Reel 6508, Frame 0287;

WHEREAS, the Grantor and the Collateral Agent agree that the grant and recordation of the security interest in the Released Trademark was erroneous; and

WHEREAS, Grantor requests a specific release of the security interest granted and recorded against the Released Trademark, and the Collateral Agent desires to release any and all security interests, and any other lien, it has on the Released Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent and the Grantor hereby agree as follows:

- (a) Grantor erroneously granted a security interest in the Released Trademark to the Collateral Agent pursuant to the First Lien Security Agreement and recorded such grant of a security interest pursuant to the Trademark Security Agreement filed with the United States Patent and Trademark Office on December 21, 2018, at Reel 6508, Frame 0287.
- (b) The Collateral Agent hereby, without representation or warranty of any kind, absolutely, unconditionally and irrevocably releases, terminates and forever discharges the security interest in the Released Trademark that was granted to the Collateral Agent under the First Lien Security Agreement and the Trademark Security Agreement.

- (c) The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Released Trademark. Bank of America agrees to perform all further acts and execute and deliver all further documents and/or instruments that may be reasonably necessary to carry out the provisions of this Release, all at Grantor's reasonable request and at the sole cost and expense of Grantor.
  
- (d) This Release shall be governed by and construed in accordance with the law of the State of New York.


