**FIRST AMENDMENT, JOINDER AND SUPPLEMENT TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This First Amendment, Joinder and Supplement to Intellectual Property Security Agreement (“Supplement”), dated as of August 31, 2021, is by and among SAVANT SYSTEMS, INC., a Delaware corporation (“Savant”), SAVANT TECHNOLOGIES LLC (f/k/a CONSUMER LIGHTING (U.S.) LLC) (“Lighting (U.S.)”, and together with Savant, collectively, “Existing Grantors” and each an “Existing Grantor”), RACEPOINT ENERGY, LLC, a Massachusetts limited liability company (“Joining Grantor”, and together with Existing Grantors, collectively, “Grantors” and each a “Grantor”) and PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent for the Lenders (in each such capacity, “Agent”).

BACKGROUND

This Supplement is being delivered in connection with (i) that certain Revolving Credit, and Security Agreement, dated as of June 30, 2020, by and among Existing Grantors, certain subsidiaries and affiliates of Existing Grantors party to the Credit Agreement from time to time as Loan Parties (as defined in the Credit Agreement), the financial institutions which are now or which hereafter become a party to the Credit Agreement (collectively, the “Lenders” and each individually, a “Lender”) and Agent (as amended, supplemented, restated, replaced, or otherwise modified from time to time, the “Credit Agreement”), and (ii) that certain Intellectual Property Security Agreement, dated as of June 30, 2020, by Existing Grantors in favor of Agent (as amended, supplemented, restated, replaced, or otherwise modified from time to time, the “IP Security Agreement”) and recorded at Reel 6985, Frame 0211 in the United States Patent and Trademark Office on June 30, 2020. Capitalized terms used but not defined herein shall have the respective meanings given to such terms in, or by reference in, the IP Security Agreement.

A. Pursuant to the Credit Agreement and the IP Security Agreement, Existing Grantors granted to Agent, for the benefit of Lenders, a lien on and security interest in all of Existing Grantor’s Copyrights, Trademarks, and Patents.

B. As of the date hereof, Joining Grantor has joined the Credit Agreement as a guarantor thereunder, and has granted to Agent a lien on all Collateral (as defined in the Credit Agreement), including Joining Grantor’s Copyrights, Trademarks and Patents.

C. On or about June 30, 2021, Existing Grantors acquired from Joining Grantor certain additional trademarks set forth on Schedule A-1 attached hereto and made part hereof (the “Additional Trademarks”) and certain additional patents set forth on Schedule A-2 attached hereto and made a part hereof (the “Additional Patents”, together with the Additional Trademarks, collectively, the “Additional Intellectual Property Collateral”).

D. Grantors and Agent desire to execute this Supplement for the purpose of, inter alia, (i) adding Joining Grantor as a “Grantor” under the IP Security Agreement, and (ii) granting, ratifying and confirming Agent’s lien on and security interest in the Additional Intellectual Property Collateral, as set forth more fully in the IP Security Agreement, and for recording in the United States Patent and Trademark Office and/or the United States Copyright Office, as applicable.

NOW THEREFORE, with the foregoing Background hereinafter deemed incorporated by reference and made a part hereof, and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Grantors, intending to be legally bound hereby, covenant and agree as follows:

1. Joinder. As of the date hereof, Joining Grantor joins in as, assumes the obligations and liabilities of, adopts the obligations, liabilities and role of, and becomes a Grantor under the IP Security Agreement. All references to "Grantor" or "Grantors" contained in the IP Security Agreement are hereby deemed for all purposes to also refer to and include Joining Grantor, and Joining Grantor hereby agrees to comply with all terms and conditions of the IP Security Agreement as if Joining Grantor was an original signatory thereto.

2. Grant and Reaffirmation of Security Interests. To secure the payment and performance of the Obligations under the Credit Agreement, each Grantor (including, for the avoidance of doubt, Joining Grantor) hereby grants to Agent, for its benefit and the benefit of Lenders, and hereby reaffirms its prior grant pursuant to the Credit Agreement of a continuing security interest in such Grantor's entire right, title and interest in and to the following whether now owned or existing or hereafter created, acquired or arising:

(a) the Additional Intellectual Property, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, such Additional Intellectual Property;

(b) all licenses or other similar rights provided or granted to Grantors in or with respect to the Additional Intellectual Property that is owned or controlled by any other person and any other license or other similar rights provided or granted by Grantors to any other person in or with respect to the Additional Intellectual Property owned or controlled by Grantors; and

(c) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of the Additional Trademark, or (b) injury to the goodwill associated with the Additional Trademark.




