Pursuant to Section 252 of the General Corporation Law of the State of Delaware

Ra Medical Systems, Inc., a California corporation, and Ra Medical Systems, Inc., a Delaware corporation, do hereby certify as follows:

FIRST: That the name and jurisdiction of organization of each of the constituent entities of the merger are as follows:

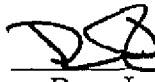
