 - e. There are no claims, pending or threatened, with respect to Assignor’s rights in the Trademark;
 - f. This Assignment is valid, binding, and enforceable in accordance with its terms in all jurisdictions pertaining hereto; and
 - g. Assignor is not subject to any agreement, judgment, or order inconsistent with the terms of this Assignment.

3. This Assignment shall become effective on the Effective Date below when executed by the respective Parties.
4. This Assignment contains the entire understanding of the Parties.
5. If any term, provision, covenant, or condition of this Assignment is held by a court of competent jurisdiction to be invalid, unenforceable or void, the remainder of this Assignment shall remain in full force and effect, except as mandated by the court ruling.
6. This Assignment and all claims or actions arising hereunder shall be construed in accordance with the laws of the State of Utah.
