**PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of September 2, 2021 (this "Release") is made by JPMorgan Chase Bank, N.A., as administrative agent for a group of lenders (in such capacity, together with its successors and permitted assigns, the "Agent") in favor of Bio-Reference Laboratories, Inc., a New Jersey corporation (the "Grantor").

The Agent, without representation, warranty or recourse of any sort, hereby terminates, releases and discharges the collateral assignment and pledge in and all of its lien on and security interest in, all right, title and interest in, to and under the Trademark. Any right, title or interest of the Agent in such Trademark shall hereby cease and become void. For the avoidance of doubt, no other lien or security interest granted to the Administrative Agent pursuant to the Security Agreement, the Trademark Security Agreement or otherwise shall be released hereby.

The Agent hereby authorizes the Grantor or the Grantor's authorized representative to (i) record this Release with the United States Patent and Trademark Office, and/or (ii) otherwise record or file this Release in the applicable governmental office or agency.

This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
