

AND, ASSIGNOR hereby covenants, agrees and will undertake to execute, whenever requested by ASSIGNEE, all trademark applications, trademark registrations, assignments, lawful oaths, documents, instruments, and any other papers which ASSIGNEE may deem necessary or desirable for securing to ASSIGNEE, or for maintaining unto ASSIGNEE, all rights hereby assigned, or agreed to be assigned, without further compensation to the undersigned ASSIGNOR.
