**RELEASE OF PATENT, COPYRIGHT, LICENSE AND TRADEMARK SECURITY
AGREEMENT**

This Release of Patent, Copyright, License and Trademark Security Agreement (this “Release”) is made as of March 31, 2021, by BSP AGENCY, LLC, as successor to Triangle Capital Corporation, in its capacity as collateral agent (in such capacity, the “Agent”) for the Purchasers under that certain Purchase Agreement referred to below, for the benefit of Captek Holdings LLC, a Delaware limited liability company, Captek Holdings Inc., a Delaware corporation, Captek Softgel International, Inc., a California corporation, and Winning Laboratories, Inc., a California corporation (each, a “Grantor”, and collectively, the “Grantors”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the IP Security Agreement.

W I T N E S S E T H:

WHEREAS, each Grantor and the Agent are parties to that certain (i) Securities Purchase Agreement dated as of February 28, 2011 (as amended, restated or otherwise modified through the date hereof, the “Purchase Agreement”); and (ii) Patent, Copyright, License and Trademark Security Agreement, dated as of February 28, 2011 (as amended, restated or otherwise modified through the date hereof, the “IP Security Agreement”), pursuant to which the Grantors have granted to the Agent for the benefit of the Purchasers party to the Purchase Agreement a lien on and security interest in all of the right, title and interest of each Grantor in, to and under the Patents, Copyrights, Marks, Licenses (as each is defined in the IP Security Agreement) and other assets of each Grantor as more specifically described in the IP Security Agreement, including the trademarks set forth on Schedule I hereto (collectively, the “Collateral”);

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office (the “USPTO”) on March 16, 2011 at Reel 4498 and Frame 0781; and

WHEREAS, the Grantors have requested that the Agent release, and the Agent is willing to release solely Agent’s lien on and security interest in, and any other right, title, and interest it may have in, to and under the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent does hereby (x) terminate, release and discharge the entirety of any and all liens or security interests that Agent may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the IP Security Agreement and any right, title or interest of the Agent in such Collateral shall hereby terminate, cease and become void and (y) terminate and cancel the IP Security Agreement. The Agent hereby assigns, transfers and conveys any and all right, title or interest of the Agent in the Collateral to the applicable Grantor.

2. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
