RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of September 1, 2021 (the “Effective Date”), is made by ROYAL BANK OF CANADA, as administrative agent for the Lenders and collateral agent for the Secured Parties (in such capacities, the “Agent”) in favor of HENRY COMPANY LLC, a California limited liability company and HENRY WDG, LLC, a Delaware limited liability company (each a “Grantor,” and together the “Grantors”). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Security Agreement, dated as of October 5, 2016, by and among the Grantors, the Agent, and certain other parties (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors executed and delivered that certain Trademark Security Agreement, dated as of October 5, 2016 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on October 5, 2016 at Reel/Frame 5891/0542 (with respect to Henry Company LLC) and at Reel/Frame 5892/0250 (with respect to Henry Wdg, LLC);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Grantor granted to the Agent a continuing security interest in and a continuing lien on (the “Security Interest”) all of such Grantor’s right, title and interest in, to and under the following, whether then owned or existing or thereafter acquired or arising (but excluding any Excluded Assets): (i) each United States Trademark constituting Recordable Intellectual Property owned by such Grantor, including, without limitation, each such Trademark registration and application referred to in Schedule 1 hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each such Trademark; (ii) each Trademark License constituting Recordable Intellectual Property to which such Grantor is a party, including, without limitation, each such Trademark License identified in Schedule 1 hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each such Trademark licensed pursuant thereto; (iii) all rights priorities and privileges with respect thereto; and (iv) all rights to sue or otherwise recover for any past, present and future infringement, dilution, misappropriation, or other violation or impairment thereof, including the right to receive all Proceeds therefrom, including, without limitation, license fees, royalties, income payments, claims, damages and proceeds of suit, then or thereafter due and/or payable with respect thereto (collectively, the “Trademark Collateral”); and

WHEREAS, the Agent and the Grantors acknowledge that the requirements for releasing the Security Interest in the Trademark Collateral have been met.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) terminates and cancels the Trademark Security Agreement, (ii) releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral, and (iii) re-assigns to each Grantor all right, title or interest it may have in the Trademark Collateral of such Grantor, in each case without recourse to the Agent and without representation or warranty of any kind.

Each Grantor, or any successor to such Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral of such Grantor), is hereby authorized to record this Release in the USPTO.

IN WITNESS WHEREOF, the Agent has caused this Release to be executed and delivered by its duly authorized representative as of the Effective Date.
