**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**, dated as August 5, 2021 (“**Release**”), is made by **SILICON VALLEY BANK**, a California Corporation, with a loan production office located at 505 Howard Street, 3rd Floor, San Francisco, California 94105 (“**Bank**”) and **TILE, INC.**, a Delaware corporation with its principal place of business located at 2121 S El Camino Real, No. C-100, San Mateo, California 94403 (“**Company**”).

WHEREAS, Company, Tile Europe Limited, Tile Network Canada ULC, and Bank entered into that certain Loan and Security Agreement, dated as of May 13, 2015 (“**Original Loan Agreement**”) (as the same may from time to time have been amended, restated, or otherwise modified, including as amended and restated by the Mezzanine Loan and Security Agreement dated as of July 13, 2017 (“**Mezzanine Loan Agreement**”) and the Amended and Restated Loan and Security Agreement dated as of July 13, 2017 (“**Amended Loan Agreement**”)) (the Original Loan Agreement, the Mezzanine Loan Agreement, and the Amended Loan Agreement, collectively comprising the “**Loan Agreements**”);

WHEREAS, pursuant to the Mezzanine Loan Agreement, Company and Bank entered into that certain Intellectual Property Security Agreement, dated as of July 13, 2017, (“**Mezzanine IP Security Agreement**”), as amended by the Addendum to Intellectual Property Security Agreement dated August 10, 2018 (“**Mezzanine IP Addendum**”), whereby Company granted to Bank a security interest in all of Company’s right, title and interest, in, to and under its Intellectual Property Collateral (as defined in the Mezzanine IP Security Agreement, as amended by the Mezzanine IP Addendum);

WHEREAS, pursuant to the Amended Loan Agreement, Company and Bank entered into that certain Intellectual Property Security Agreement, dated as of July 13, 2017 (“**IP Security Agreement**”), as amended by the Addendum to Intellectual Property Security Agreement dated August 10, 2018 (“**IP Addendum**”) whereby Company granted to Bank a security interest in all of Company’s right, title and interest, in, to and under its Intellectual Property Collateral (as defined in the IP Security Agreement, as amended by the IP Addendum);

WHEREAS, pursuant to the Amended Loan Agreement, Company and Bank entered into that certain Amended and Restated Intellectual Property Security Agreement, dated as of August 24, 2020 (“**Amended IP Security Agreement**”), whereby Company granted and pledged to Bank a security interest in all of Company’s right, title and interest in, to and under its Intellectual Property Collateral (as defined in the Amended IP Security Agreement) (the Mezzanine IP Security Agreement, the Mezzanine IP Addendum, the IP Security Agreement, the IP Addendum, and the Amended IP Security Agreement, collectively comprising the “**Security Agreements**”);

WHEREAS, the Mezzanine IP Security Agreement was recorded against certain patents and/or patent applications at the United States Patent and Trademark Office (“**USPTO**”) on July 13, 2017, at Reel 043001, Frame 0204;

WHEREAS, a “Corrective Assignment to correct the INCORRECTLY IDENTIFIED PATENT APPLICATION NUMBER 15430056 TO PROPERLY REFLECT PATENT”

APPLICATION NUMBER 15439056 previously recorded on Reel 043001 Frame 0204” was recorded against certain patents and/or patent applications at the USPTO on September 15, 2020, at Reel 053797, Frame 0016;

WHEREAS, the Mezzanine IP Addendum was recorded against certain patents and/or patent applications at the USPTO on August 13, 2018, at Reel 046623, Frame 0708;

WHEREAS, the IP Security Agreement was recorded against certain patents and/or patent applications at the USPTO on July 13, 2017, at Reel 043001, Frame 0082;

WHEREAS, a “Corrective Assignment to correct the INCORRECTLY IDENTIFIED PATENT APPLICATION NUMBER 15430056 TO PROPERLY REFLECT PATENT APPLICATION NUMBER 15439056 previously recorded on Reel 043001 Frame 0082” was recorded against certain patents and/or patent applications at the USPTO on September 15, 2020, at Reel 053797, Frame 0050;

WHEREAS, the IP Addendum was recorded against certain patents and/or patent applications at the USPTO on August 14, 2018, at Reel 046797, Frame 0428.

WHEREAS, the Mezzanine IP Security Agreement was recorded against certain trademarks and/or trademark applications at the USPTO on July 13, 2017, at Reel 006104, Frame 0794;

WHEREAS, the Mezzanine IP Addendum was recorded against certain trademarks and/or trademark applications at the USPTO on August 13, 2018, at Reel 006411, Frame 0386;

WHEREAS, the IP Security Agreement was recorded against certain trademarks and/or trademark applications at the USPTO on September 13, 2017, at Reel 006104, Frame 0759;

WHEREAS, the IP Addendum was recorded against certain trademarks and/or trademark applications at the USPTO on August 13, 2018, at Reel 006411, Frame 0377; and

WHEREAS, pursuant to that certain Termination Letter, dated as of August 5, 2021, by and between Bank, Company, Tile Europe Limited, and Tile Network Canada ULC, Bank terminated the Loan Agreements and terminated and automatically released all security interests thereunder.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Company and Bank agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the IP Security Agreement or the Loan Agreement.

SECTION 2. Termination and Release. Bank, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of **Company's** right, title and interest in, to and under its Intellectual Property Collateral, as defined in the Loan Agreements and the Security Agreements, including, without limitation, the following:

(i) Any and all copyright rights, copyright applications, copyright registrations and like protections in each work of authorship and derivative work thereof, whether published or unpublished and whether or not the same also constitutes a trade secret, now or hereafter existing, created, acquired or held, including without limitation those set forth on Exhibit A attached hereto (collectively, the **"Copyrights"**);

(ii) Any and all trade secrets, and any and all intellectual property rights in computer software and computer software products now or hereafter existing, created, acquired or held;

(iii) Any and all design rights that may be available to Grantor now or hereafter existing, created, acquired or held;

(iv) All patents, patent applications and like protections including, without limitation, improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same, including without limitation the patents and patent applications set forth on Exhibit B attached hereto (collectively, the **"Patents"**);

(v) Any trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor connected with and symbolized by such trademarks, including without limitation those set forth on Exhibit C attached hereto (collectively, the **"Trademarks"**);

(vi) All mask works or similar rights available for the protection of semiconductor chips, now owned or hereafter acquired, including, without limitation those set forth on Exhibit D attached hereto (collectively, the **"Mask Works"**);

(vii) Any and all claims for damages by way of past, present and future infringements of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights identified above;

(viii) All licenses or other rights to use any of the Copyrights, Patents, Trademarks, or Mask Works and all license fees and royalties arising from such use to the extent permitted by such license or rights;

(ix) All amendments, extensions, renewals and extensions of any of the Copyrights, Trademarks, Patents, or Mask Works; and

(x) All proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.

(b) authorizes the recordation of this Release with the USPTO at Company's expense.

SECTION 3. Choice of Law. This Agreement and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Agreement and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of California, without giving effect to any choice or conflict of law provision or rule (whether of the State of California or any other jurisdiction).
