## TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release"), dated as of September 1, 2021, is executed by JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent for the Lenders (together with its successors, the "Administrative Agent"), in favor of CORE-MARK DISTRIBUTORS, INC. (successor by merger with J. T. Davenport & Sons, Inc.) a Georgia corporation (the "Grantor"). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement (as defined below).

### RECITALS

A. WHEREAS, the Grantor has, pursuant to that certain Trademark Security Agreement dated as of February 14, 2014, recorded in the United States Patent and Trademark Office (the "USPTO") on February 21, 2014 at Reel 5221, Frame 0472 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the "Trademark Security Agreement") granted to the Administrative Agent, for the benefit of the Lenders, a continuing first priority security interest in all of the Grantor's right, title and interest in, to and under the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the "Released Collateral"); and

B. WHEREAS, the Administrative Agent wishes to terminate and release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this Release.

C. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby:

1. terminates and releases, without recourse, representation or warranty, all of its security interest in and to the Released Collateral and other rights, title and interest in, to and under the Released Collateral, whether granted pursuant to the Trademark Security Agreement or any other agreement or document delivered in connection with the Pledge and Security Agreement ("Security Agreement"), dated as of October 12, 2005 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof), by and among, *inter alios*, the Grantor and the Administrative Agent;
2. terminates the Trademark Security Agreement;
3. reassigns, retransfers and reconveys any and all right, title and interest (if any) that the Administrative Agent may have in, to and under the Released Collateral granted to Administrative Agent pursuant to the Trademark Security Agreement or any other agreement or document delivered in connection with the Security Agreement to the Grantor; and
4. agrees to provide the Grantor with any information and additional authorization necessary to effect the release of the security interest in the Released Collateral.

The Administrative Agent hereby authorizes and requests that this Release be filed along with any other necessary documentation with the USPTO or any other governmental office to

evidence the release granted herein at the sole expense of the Grantor. The Administrative Agent authorizes the Grantor to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.



