**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this “Release”), dated as of September 2, 2021, is made by Freeport Financial Partners LLC, in its capacity as administrative agent (the “Agent”), in favor of United Skin Specialists LLC, a Delaware limited liability company (the “Grantor”), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain Guaranty and Security Agreement dated as of October 14, 2016 (as amended, supplemented or otherwise modified from time to time, the “Guaranty and Security Agreement”), among the Grantor and the other parties party thereto in favor of the Agent, and those certain agreements described on Annex I attached hereto (the “Trademark Security Agreements”), the Grantor granted a security interest in certain collateral in favor of the Agent, including the Trademark Collateral (as hereinafter defined); and

WHEREAS, the Agent now desires to terminate and release the Trademark Security Agreements and the entirety of its security interest in the Trademark Collateral described on Annex II attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby agrees as follows:

1. Definitions. The term “Trademark Collateral”, as used herein, shall mean all of the Grantor’s right, title or interest in, or to any and all of the trademarks listed on Annex II attached hereto. Capitalized terms not defined herein have the meanings set forth in the Guaranty and Security Agreement or Trademark Security Agreements, as applicable.

2. Release of Security Interest. The Agent, without recourse, representation or warranty and at the Grantor’s sole cost and expense, hereby terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantor, and its successors and assigns, its security interest in and to the Trademark Collateral, the Trademark Security Agreements and any and all right, title and interest of the Agent in, to and under the Trademark Collateral shall hereby be terminated, cancelled, released, relinquished and discharged. The Agent hereby authorizes the Grantor and its successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office, at the sole expense of the Grantor, to evidence and effectuate the release and termination of the Agent’s security interest in the Trademark Collateral.


