RELEASE OF TRADEMARK SECURITY INTEREST

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby terminates the Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreement in any and all right, title and interest of the Company, and reassigns to the Company any and all right, title and interest that it may have, in to and under the “Collateral” as defined in the Security Agreement.

Lender hereby represents and warrants that it has not assigned any interest in the Collateral and has the unqualified right to enter into this release and perform its terms.
