TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“Assignment”) is entered into on the date last signed below (the “Effective Date”) by and between by Exeter Property Group, a Delaware limited liability corporation, having an address at Suite 600, 101 West Elm Street Conshohocken, Pennsylvania 19428 (“Assignor”), and EQT AB, a Swedish corporation, having an address at Regeringsgatan 25 Stockholm, Sweden SE-111 53 (“Assignee”).

WHEREAS, Assignor desires to assign all of its right, title, and interest in and to the mark, EXETER PROPERTY GROUP (the “Mark”), including the goodwill associated with the Mark, to Assignee; and

WHEREAS, Assignee is desirous of acquiring all of Assignor’s right, title, and interest in and to the Mark.

NOW, THEREFORE, for \$50,000.00 (fifty thousand United States dollars), the receipt and sufficiency of which are hereby acknowledged:

1. Assignor hereby assigns, transfers and sets over to Assignee its entire right, title, and interest in and to the Mark, including any and all goodwill of the business connected with the use thereof and symbolized thereby, all registrations therefor, including the US Reg. No. 5463392, all common law rights that exist therein, any and all trademark and/or service mark rights related thereto and in and to any and all causes of action (either in law or in equity), as well as the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present, or future infringement, misappropriation and/or dilution of the Mark.

2. Assignor hereby authorizes and requests the U.S. Patent and Trademark Office to record Assignee as the owner of the Mark.

3. This Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. This Assignment may not be amended except by an instrument in writing signed by each of the parties.
