RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is made as of September 3, 2021, by GLAS TRUST CORPORATION LIMITED, in its capacity as Collateral Agent (the "Collateral Agent"), in favor of EXCEL PARTNERSHIP, INC., SAI GLOBAL INC. and SAI GLOBAL COMPLIANCE, INC. (each individually, a "Grantor" and collectively, the "Grantors"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Second Lien Intellectual Property Security Agreement (defined below), or if not defined therein, in the Security Agreement (defined below).

WHEREAS, each Grantor is a party to that certain (i) Second Lien Security Agreement, dated as of December 23, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") in favor of the Collateral Agent, and (ii) Second Lien Intellectual Property Security Agreement, dated as of December 23, 2016, in favor of the Collateral Agent (the "Second Lien Intellectual Property Security Agreement"), pursuant to which each Grantor pledged, assigned, transferred and granted to the Collateral Agent a continuing security interest in all right, title and interest of such Grantor in, to and under the Intellectual Property Collateral;

WHEREAS, the Second Lien Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5951, Frame 0546 on December 23, 2016;

WHEREAS, each Grantor has requested that the Collateral Agent terminate, release and discharge fully its continuing security interest in all right, title and interest of such Grantor in, to and under the Intellectual Property Collateral, including (i) all Trademarks and Trademark Licenses to which it is a party, including those referred to on the attached Schedule A hereto, (ii) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; (iii) all reissues, continuations or extensions of the foregoing; and (iv) all Proceeds of the foregoing, including any claim by Grantor against third parties for past, present, future infringement or dilution of any Trademark or Trademark licensed under any Trademark License or injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License (collectively, the "Trademark Collateral");

WHEREAS, the Grantor has requested that the Collateral Agent execute this Release to evidence the release of its continuing security interest in the Trademark Collateral in the United States Patent and Trademark Office, as herein provided.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without representation or warranty of any kind, hereby releases, relinquishes and discharges its continuing security interest in, to and under the Trademark Collateral, and re-assigns to each Grantor any and all right, title or interest it may have in the Trademark Collateral of such Grantor.

The Collateral Agent hereby authorizes each Grantor, or each Grantor's authorized representatives, including any person or entity hereafter having any right, title or interest in, to or under the Trademark Collateral of such Grantor to record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency. The Collateral Agent agrees to execute and deliver to the Grantors other instruments and other documents, and do all further acts which the Grantor (or its agents or designees) reasonably request, at the Grantor's sole cost and expense, as may be necessary to release the lien on and security interest in the Intellectual Property Collateral which had been granted under the Second Lien Intellectual Property Security Agreement.

THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES
HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED
IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD
TO CONFLICT OF LAWS PRINCIPLES THEREOF THAT WOULD RESULT IN THE
APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK
(OTHER THAN ANY MANDATORY PROVISIONS OF LAW RELATING TO THE LAW
GOVERNING PERFECTION AND THE EFFECT OF PERFECTION OF THE SECURITY
INTEREST).


