The undersigned, for the purpose of converting TVC Holding Inc., a corporation formed under the laws of the State of Oklahoma, to TVC Holding, LLC, a Delaware limited liability company, pursuant to Section 1090.5 of Title 18 of the Oklahoma Statutes, does hereby execute the following Certificate of Conversion:

1. Date Business Entity First Formed. The date on which TVC Holding Inc. was first formed was September 25, 1996.
2. Name and Jurisdiction of Formation of Business Entity. The name of the business entity when formed was JVL Holding Properties Inc., and the jurisdiction of formation of such business entity when formed is Oklahoma. The name of the business entity immediately prior to the filing of this Certificate of Conversion was TVC Holding Inc., and the jurisdiction of formation of such business entity immediately prior to the filing of this Certificate of Conversion is Oklahoma.
3. Name of Limited Liability Company. The name of the limited liability company to which TVC Holding Inc. shall be converted is TVC Holding, LLC, and its jurisdiction of formation is Delaware.

5. Compliance With Section 1090.5. The conversion of TVC Holding Inc. to TVC Holding, LLC was approved in all respects in accordance Section 1090.5 of Title 18 of the Oklahoma Statutes.
6. Service of Process by Secretary of State. TVC Holding, LLC (1) agrees that it may be served in this state in a proceeding for the enforcement of an obligation of TVC Holding Inc. in any action or special proceeding for the enforcement of any liability or obligation of TVC Holding Inc., previously amenable to suit in this state, and for the enforcement, of the right of the shareholders of TVC Holding Inc. to receive payment for their interests against TVC Holding, LLC; (2) hereby irrevocably appoints the Secretary of State as TVC Holding, LLC's agent for service of process, and agrees that the Secretary of State may forward a copy of any service of process on TVC Holding, LLC to the following address: 3200 W. Wilshire Blvd., Oklahoma City, Oklahoma 73116; and (3) agrees that TVC Holding, LLC will promptly pay to the shareholders of TVC Holding Inc. the amount, if any, to which they shall be entitled under Oklahoma law to receive payment for their interests.
