TRADEMARK ASSIGNMENT

This Trademark Assignment Agreement (this "Assignment") is made and delivered as of September 9, 2021 (the "Effective Date") by Clark Equipment Company, a Delaware corporation (the "Assignor"), for the benefit of Doosan Infracore North America LLC, a Delaware limited liability company (the "Assignee") (Assignor and Assignee are collectively referred to herein as the "Parties").

WHEREAS, the Assignor agrees to transfer and assign to the Assignee all of the Assignor's right, title, and interest in and to the Assignor's trademark DOMORE, U.S. Reg. No. 4025876 (the "Mark"), together with the goodwill of the business associated therewith.

NOW, THEREFORE, in consideration of the Assignment and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby agrees as follows:

1. The Assignor hereby irrevocably assigns and transfers to the Assignee: (i) all of the Assignor's right, title, and interest in and to the Mark, together with the goodwill associated therewith; (ii) any and all legal actions and rights and remedies at law or in equity for past infringements, misappropriations, or other violations of the Mark, including the right to sue for, collect, and retain all damages, profits, proceeds, and all other remedies associated therewith; and (iii) any and all income, royalties, and payments accruing on or after the Effective Date with respect to the Mark, for the Assignee's own use and enjoyment and for the enjoyment of the Assignee's successors, assigns, or other legal representatives. The Assignor agrees to give the Assignee and/or any person designated by the Assignee all reasonable assistance that may be required to perfect the rights granted herein.

3. The Assignor authorizes and requests the Director of the United States Patent and Trademark Office, and any other official throughout the world whose duty is to register and record ownership in trademark registrations and applications for registration of trademarks, to record the Assignee as the assignee and owner of any and all of the Assignor's rights in the Mark.

4. All of the terms and provisions of this Assignment shall inure to the benefit of and be binding upon the Parties hereto and their respective successors and assigns.

5. No provision of this Assignment is intended to confer upon any person other than the Parties hereto and their respective successors and assigns any rights or remedies hereunder.

6. This Assignment shall be governed by and interpreted and enforced in accordance with the laws of the State of North Dakota.
