(the "Company"), pursuant to the authority granted by Sections 1701.69 and 1701.70(B)(6) of the Ohio Revised Code, hereby declares that the Articles of Incorporation of the Company are amended by deleting the Article First thereof in its entirety and inserting the following in lieu thereof:
