**TERMINATION OF TRADEMARK SECURITY AGREEMENT AND
RELEASE OF SECURITY INTEREST**

This Termination of Trademark Security Agreement (this "**Agreement**") is entered into effective as of the 1st day of September, 2021, by and between Summit Brewing Company, a Minnesota corporation (the "**Borrower**") and Associated Bank, National Association, a national banking association (the "**Bank**").

1. The Borrower previously entered into that certain Trademark Security Agreement dated as of July 15, 2016 in favor of the Bank (the "**Agreement**"), pursuant to which Borrower assigned and granted to the Bank a security interest in Borrower's rights, title and interest in and to the Borrower's trademarks including those identified in the attached Exhibit A (the "**Trademarks**").


2. The Borrower and the Bank hereby agree that the Agreement is hereby terminated effective as of the date hereof and shall be of no further force or effect whatsoever. Accordingly, the Bank releases and terminates any and all of its security interest that it has pursuant to the Trademark Security Agreement in the Trademarks and reassigns to the Debtor any and all right, title and interest that the Bank may have in and to the Trademarks.

3. This Agreement may be executed in any number of counterparts, each of which may be executed by less than all of the Parties, all of which together will constitute one instrument and will be enforceable against the Parties. This Agreement may be executed by facsimile signature or any electronic signature complying with the U.S. federal ESIGN Act of 2000 (e.g., www.docusign.com), such signature is deemed an original signature. Copies of the execution copy of this Agreement or any amendment with one or more signatures sent by facsimile transmission or as a "PDF" (portable document file) attached to an electronic mail message or other transmission method and any counterpart so delivered is deemed to have been duly and validly delivered and are valid, fully enforceable, and effective for all purposes without a manually executed original.


