TERMINATION OF TRADEMARK SECURITY AGREEMENTS

WHEREAS, James Perse Enterprises, Inc., a California corporation (the “Grantor”), and The Bank of New York Mellon, a New York banking corporation, as Collateral Agent for the Secured Parties (in such capacity and together with its successors and assigns in such capacity, the “Collateral Agent”), entered into a certain Trademark Security Agreement, dated as of July 29, 2014, (the “Trademark Security Agreement”), which was recorded at the United States Patent and Trademark Office on July 31, 2014 at Reel 5333 and Frame 0664, and a First Supplemental Trademark Security Agreement, dated as of April 20, 2020 (the “First Supplemental Trademark Security Agreement”), which was recorded at the United States Patent and Trademark Office on April 20, 2020 at Reel 6918 and Frame 0876. Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Trademark Security Agreement and First Supplemental Trademark Security Agreement, as applicable.

WHEREAS, pursuant to the Trademark Security Agreement and First Supplemental Trademark Security Agreement, the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in, all of Grantor’s right, title and interest in and to the Trademark Collateral and Additional Trademark Collateral, including the trademarks, trademark applications and trademark registrations set forth on Exhibit A appended hereto (collectively, the “Trademarks”).


WHEREAS, the Collateral Agent now desires to terminate and release the security interest in the Trademark Collateral and the Additional Trademark Collateral, including the Trademarks.

NOW THEREFORE, the Collateral Agent hereby terminates, cancels, discharges, and releases the security interest in and lien upon, any and all of the Trademark Collateral and the Additional Trademark Collateral, including the Trademarks, in which Collateral Agent was granted a security interest under the Trademark Security Agreement and the First Supplemental Trademark Security Agreement, in each case without recourse or representation or warranty, express or implied, of any kind.
