PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

This PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of August 2, 2021 (the "Effective Date"), is made by CITIBANK, N.A., as collateral agent for the Secured Parties (in such capacity, the "Collateral Agent") in favor of PQ CORPORATION, a Pennsylvania corporation ("PQ"). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain ABL Pledge and Security Agreement among PQ, the other Loan Parties party thereto, and the Collateral Agent, dated as of May 4, 2016 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), PQ and certain other Grantors executed and delivered that certain Trademark Security Agreement, dated as of May 4, 2016 (the "Trademark Security Agreement"), which was recorded with the United States Patent and Trademark Office ("USPTO") on June 1, 2016 at Reel/Frame 5804/0819;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, PQ pledged, collaterally assigned, mortgaged, transferred and granted to the Collateral Agent, its successors and permitted assigns, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest (the "Security Interest") in all of PQ's right, title and interest in, to and under the following assets, whether then owned by or owing to, or thereafter acquired by or arising in favor of PQ, and regardless of where located: (a) all trademarks (including service marks), common law marks, trade names, trade dress, and logos, slogans and other indicia of origin under the laws of any jurisdiction in the world ("Trademarks"), and the registrations and applications for registration thereof and the goodwill of the business symbolized by the foregoing, including those registrations and applications in the USPTO listed on Schedule I hereto; (b) all renewals of the foregoing; (c) all income, royalties, damages, and payments then or thereafter due or payable with respect to the Trademarks, including, without limitation, damages, claims, and payments for past, present and future infringements and dilutions thereof; (d) all rights to sue for past, present, and future infringements and dilutions thereof, including the right to settle suits involving claims and demands for royalties owing; and (e) all rights corresponding to any of the foregoing; in each case to the extent constituting Collateral (the "Released Trademark Collateral"); and

WHEREAS, the Collateral Agent and PQ acknowledge that the requirements for releasing the Security Interest in the Released Trademark Collateral have been met.


NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (a) releases, discharges, terminates and cancels the Security Interest in the Released Trademark Collateral and (b) irrevocably re-assigns and re-transfers to PQ any right, title or interest it may have in, to or under the Released Trademark Collateral of PQ, in each case without recourse to the Collateral Agent and without representation or warranty of any kind. For the avoidance of doubt, except as expressly set forth above, nothing herein shall affect the Security Interest held by the Collateral Agent in the Trademark Collateral or any other security interest granted by PQ or any other Grantors to the Collateral Agent.

PQ, or any successor to PQ (including any person or entity hereafter having any right, title or interest in or to the Released Trademark Collateral of PQ), is hereby authorized to deliver this Release to evidence the release of the Collateral Agent's security interest in the Released Trademark Collateral for filing and recordation with the USPTO.
