TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of September 10, 2021, and made by **GOLUB CAPITAL LLC** (the "Grantee"), to **VENDA VO, INC.**, a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of October 16, 2014, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on October 17, 2014 at Reel/Frame 5382/0921;

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Exhibit A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its continuing first priority security interest in the Trademark Collateral (as defined in the Security Agreement), including Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest that Grantee may have in the Intellectual Property.


