## ASSIGNMENT OF TRADEMARK RIGHTS

This ASSIGNMENT OF TRADEMARK RIGHTS is made effective as of the 1<sup>st</sup> day of May, 2021 by and between OSRAM SYLVANIA Inc., a Delaware Corporation (“Assignor”), and Digital Lumens Incorporated, a Delaware Corporation (“Assignee”).

### WITNESSETH:

WHEREAS, Assignor and Assignee entered into that certain Local Asset Transfer Agreement United States are parties to that certain Asset Purchase Agreement, made effective as of May 1, 2021 (“the LATA Agreement”); and

WHEREAS, pursuant to the LATA Agreement, Assignor conveys to Assignee the trademarks listed on Schedule 5.2 attached hereto (collectively referred to as the “Transferred Trademarks”)

NOW, THEREFORE, intending to be legally bound, and in consideration of the mutual covenants and agreements set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Pursuant to the Section 5.2 of the LATA Agreement, and for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby conveys, transfers, and assigns to Assignee all of Assignor’s right, title, and interest in and to the Transferred Trademarks, together with all of the goodwill of the business symbolized by the Transferred Trademarks and all rights to sue for past, present, and future infringement or misappropriations of the Transferred Trademarks including all claims, in particular damage claims, against any third parties (excluding Affiliates of Assignor) in relation to an infringement of the Transferred Trademarks in the Assignor’s portion of the CBA business of the OSRAM Group prior to May 1, 2021.
2. Further Assurances. Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the Transferred Trademarks. Assignor will perform all acts, including executing documents or certificates, as may be reasonably required by the Assignee in order to carry out the intent and purposes of the Assignment of Trademark Rights, provided, however, that Assignee will bear all costs of any such acts and will promptly reimburse Assignor its reasonable costs incurred in taking any such acts.
3. Miscellaneous. This Assignment of Trademark Rights (a) is executed pursuant to the LATA Agreement and may be executed in multiple counterparts, each of which as so executed shall be deemed an original, but all of which together shall constitute

one instrument, and (b) will be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns. To the extent that this Assignment of Trademark Rights may conflict with one or more terms of the LATA Agreement, the terms of the LATA Agreement will control.

IN WITNESS WHEREOF, each of Assignor and Assignee has caused this Assignment of Trademark Rights to be duly executed as of the date first written above.
