RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of September 13, 2021, by COMERICA BANK, a Texas banking association ("Bank") in favor of CAERUS MARKETING GROUP, LLC, a California limited liability company ("Caerus") and STUDYKIK GROUP, LLC, a California limited liability company ("Group"; with Caerus, collectively, "Grantors", and each, a "Grantor") with their principal place of business located at 17875 Von Karman Ave., Suite 200, Irvine, CA 92614-6273 (this "Release").

Recital

WHEREAS Grantors granted to Bank a security interest in all Intellectual Property (as defined in the Security Agreement), including but not limited to, the copyrights, patents and trademarks described on Exhibits A, B and C attached hereto (collectively, the "Intellectual Property Collateral"), pursuant to that certain Intellectual Property Security Agreement dated as of June 23, 2017, by and between Grantors and Bank, as amended from time to time (the "Security Agreement") and recorded with the United States Copyright Office ("USCO") as set forth on Exhibit A and recorded with the United States Patent and Trademark Office ("USPTO") as set forth on Exhibits B and C.

WHEREAS Grantors have no outstanding obligations to Bank under the terms of the Security Agreement and Bank agrees to release its security interest in the Intellectual Property Collateral, including, but not limited to the foregoing listed on Exhibits A, B and C attached hereto, and retransfer and reassign to Grantor without recourse all of Bank's right, title and interest in and to the Intellectual Property Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

SECTION 2. Termination and Release. Bank without representation, warranty, or recourse, hereby terminates, cancels, discharges, and releases any and all security interest, right, title or other interest it may have in the Intellectual Property Collateral, including, but not limited to, the foregoing listed on Exhibit A, Exhibit B, and Exhibit C attached hereto, granted pursuant to the Security Agreement, any and all right, title and interest it may have in and to the Intellectual Property Collateral together with the goodwill of the business symbolized thereby.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of California.
