**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK COLLATERAL**

This Termination and Release (this “**Release**”) is made with regard to that certain Intellectual Property Security Agreement entered into as of August 5, 2016, by and between INVOICE2GO, INC., a Delaware Corporation (the “**Company**”), VENTURE LENDING & LEASING VII, INC. (“**VLL7**”), and VENTURE LENDING & LEASING VIII, INC. (“**VLL8**”), and that certain Intellectual Property Security Agreement entered into as of September 28, 2018, by and between the Company, VLL8 and VENTURE LENDING & LEASING IX, INC. (“**VLL9**”, and together with VLL7 and VLL8, the “**Lenders**”, and each, a “**Lender**”) (together, the “**Agreements**”, and each, an “**Agreement**”).

WHEREAS, pursuant to the Agreements, which were recorded on August 8, 2016 at Reel 5849 Frame 0264 and on October 1, 2018 at Reel 6447 Frame 0173, respectively, in the U.S. Patent and Trademark Office, the Company granted the Lenders security interests (collectively, the “**Security Interest**”) in certain Trademarks, as defined in each Agreement, including the trademarks listed in Trademark Schedule A hereto (collectively, the “**Trademarks**”).

WHEREAS, the Company has been discharged in full of all of its obligations (as defined in each Agreement) under each Agreement, and the parties desire to enter into this Release to confirm that the Lender has released its security interests in and to the Trademarks and the parties desire to enter into this Release to confirm this fact and to expunge any recordation of the Security Interest insofar as it pertains to the Trademarks.

NOW, THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender forever releases and discharges the entire Security Interest in and to all of the Trademarks granted to the Lenders by the Agreements.

Each Lender hereby agrees to execute such instruments, to take such other actions, and to give such further assurances as the Company reasonably shall request to terminate any security interest in the Trademarks pursuant to the Agreements and otherwise to effectuate the release of all recordations of such Security Interest.

Each Lender acknowledges and agrees that the Company and its successors and assigns may rely upon this Release. Each Lender represents and warrants that it has not transferred or assigned all or any part of the Security Interest in the Trademarks to any third party, and that it has all necessary authority to execute this Release and grant the releases and discharges and all other rights set forth herein.
