**RELEASE AND TERMINATION
OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

THIS RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of September 15, 2021 (this “Release”), is made by GOLDMAN SACHS PRIVATE MIDDLE MARKET CREDIT LLC, a Delaware limited liability company, acting in its capacity as administrative agent for the Secured Parties (in such capacity, the “Administrative Agent”) under that certain Trademark Security Agreement, dated as of September 3, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “Trademark Security Agreement”), by R.J HEALTH SYSTEMS INTERNATIONAL, LLC, a Connecticut limited liability company, with an address of 237 Main Street, 1st Floor, Middletown, CT 06457 (the “Grantor”) in favor of the Administrative Agent.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on September 3, 2019 at reel 6735, frame 0494, the Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a lien on and security interest in and to, all of the Grantor’s right, title and interest in, to and under its owned or thereafter acquired U.S. federal trademark registrations and applications, including those set forth on the attached Schedule I (the “Trademark Collateral”);

WHEREAS, pursuant to that certain Payoff Letter, dated as of September 15, 2021, by and between the Grantor, the other signatories party thereto and the Administrative Agent, the Grantor has requested and the Administrative Agent has agreed to (a) release any and all liens and security interests it may have in the Trademark Collateral pursuant to the Trademark Security Agreement and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release and relinquish its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Trademark Collateral. The Administrative Agent agrees, or authorizes the Grantor, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantor to evidence the release and termination of the Administrative Agent’s security interests in the Trademark Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
