DEED OF IP ASSIGNMENT

PARTIES

BETWEEN **Boundary Bend Wellness, Inc.**, a United States company with a registered address at 455 Harter Avenue, Woodland, California, 95776 United States

("the Assignor")

AND **Boundary Bend IP Pty Ltd**, ACN 622 856 366, an Australian company with a registered address at 151 Broderick Road, Lara, Victoria, 3212 Australia

("the Assignee")

INTRODUCTION

- A. The Assignor is the owner of the existing intellectual property in Schedule 1 ("the Trademarks").
- B. The Assignor intends to assign the Rights to the Trademarks, together with the benefit of any use of the Trademarks by the Assignor, the goodwill of the business relations to the Trademarks and to the wares or services associated with it, to hold unto the Assignee absolutely and all other Rights to the Assignee on the terms and conditions of this Deed.

IT IS AGREED AS FOLLOWS:

- 1. "Rights" means all right, title and interest in and all rights subsisting in, or which may subsist anywhere in the world, or be conferred on the Assignor's intellectual property anywhere in the world, including without limitation:
 - a. all rights conferred by statute, common law or in equity and subsisting anywhere in the world in relation to:
 - i. registered and unregistered copyright;
 - ii. inventions (including patents, innovation patents and utility models), including those in Schedule 1;
 - iii. confidential information (including the right to enforce an obligation to keep information confidential), trade secrets, technical data and know-how;
 - iv. registered and unregistered designs;
 - v. registered and unregistered trademarks; and
 - vi. software, circuit layout designs, topography rights and rights in databases, whether or not any of these are registered, registrable or patentable;
 - b. any other rights resulting from intellectual activity in the industrial, commercial, scientific, literary or artistic fields which subsist or may hereafter subsist;
 - c. any domain name registrations;


- d. any licence or other similar right from a third party to use any of the above;
 - e. any applications and the right to apply for registration of any of the above; and
 - f. any rights of action against any third party in connection with the rights included in paragraphs (a) to (e) above, including any right to claim (and retain) any damages and other remedies (including an account of profits) for infringement.
2. For the sum of ten dollars (AUD\$10) and other good and valuable consideration (the receipt of which is acknowledged by the Assignor), the Assignor with effect from the date of this Deed, to the extent it has not already done so, irrevocably and unconditionally assigns all current and future Rights in the Trademarks to the Assignee, including any and all associated goodwill, common law and other intellectual property rights, together with (i) the benefit of any use of the Trademarks by the Assignor (ii) the goodwill of the business relations to the Trademarks and to the wares or services associated with it, (iii) all income, royalties and damages hereafter due or payable to Assignor with respect to the Trademarks to hold unto the Assignee absolutely.
 3. The Assignor will execute any document and do all things reasonably requested by the Assignee to allow the Assignee to give full effect to this Deed and the transactions contemplated by it and to otherwise obtain, enforce or defend any Rights.
 4. This Deed contains the entire agreement and understanding between the parties with respect to its subject matter and supersedes all prior agreements and understandings between the parties in connection with it.
 5. This Deed may be amended only by another deed executed by both parties.
 6. The rights and obligations provided in this Deed survive the cessation of any relationship between the Assignor and the Assignee.
 7. This Deed is governed by the laws of Victoria, Australia and each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of courts exercising jurisdiction there.
 8. This Deed may be executed in any number of counterparts. All counterparts together will be taken to constitute one instrument.




