RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of August 31, 2021, by CIBC Bank USA (the "Secured Party"), in favor of Review Trackers Inc., a Delaware corporation (the "Debtor").

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of July 23, 2019, executed by the Debtor in favor of the Secured Party (the "Security Agreement") and recorded in the records of the United States Patent and Trademark Office on August 30, 2019 at Reel/Frame 6733/00157, the Debtor granted to the Secured Party a security interest in, and a lien upon, all of the Debtor's right, title, and interest in and to the trademarks, trademark registrations, trademark applications, and any and all goodwill associated therewith (the "Marks") set forth on Schedule A attached hereto and all of the goodwill of the business(es) with which the Marks are associated (collectively the "IP Collateral").


FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, the Secured Party hereby (a) terminates and releases all liens and security interests granted by the Debtor in favor of the Secured Party in the IP Collateral and (b) assigns, transfers, and delivers to the Debtor all of its right, title, and interest in and to the IP Collateral to the extent that any such right, title, and interest exists as of the date hereof. The Secured Party hereby authorizes the Debtor or its designee to make filings with the United States Patent and Trademark Office and take further actions necessary to evidence the release and termination of the Secured Party's security interests and liens in the IP Collateral. The Secured Party hereby authorizes the governing body of the United States Patent and Trademark Office to record this Release.
