
WHEREAS, Assignor executes this Assignment to confirm and put third parties on notice of the transfer described above;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and effective as of the date of and subject to the terms and conditions of the Agreement, Assignor does hereby, sell, assign, set over, transfer, and convey to Assignee the entire right, title, and interest in and to the Marks together with the goodwill of the business connected with the use of and symbolized by the Marks and all attendant rights, the same and the rights of Assignor to be held and enjoyed by Assignee for its own use and enjoyment, and for use and enjoyment of its successors, assigns, or other legal representatives, as fully or entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made, together with all registrations and applications for registrations of the Marks throughout the world, all claims for legal and equitable relief of any kind by reason of past, present, or future infringement of said Marks, with the right to sue for and obtain the same for its own use and behalf, and for the use of its successors, or other legal representatives.
