**RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS AND PATENTS**

This Release of Grant of Security Interest in Trademarks and Patents is in relation to a certain Grant of Security Interest in Trademarks and Patents, dated March 5, 2010 (the "Security Interest"), by and between Vita Foods Products, Inc.
