**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN
TRADEMARKS**

This **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS** (this "Termination and Release") is granted as of September 15, 2021 by BMO HARRIS BANK, N.A. ("Grantee"), in favor of LANAIR PRODUCTS, LLC, a Delaware limited liability company (the "Grantor").



NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby: (1) terminates the grants and releases, terminates and discharges all liens and security interests in the Grant, all right, title and interest in, to and under the Trademark Collateral, and all goodwill associated therewith, including those trademarks identified in Schedule A hereto; and (2) authorizes and requests that this Termination and Release be recorded with the USPTO.
