**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of September 16, 2021 (“Release”), is made by Regions Bank, an Alabama bank (together with its successors and assigns, “Lender”) in favor of Xpress Global Systems, LLC, a Georgia limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Loan and Security Agreement dated as of December 4, 2019 (as amended, amended and restated, supplemented and/or otherwise modified from time to time, the “Security Agreement”) by and among the Grantor, Lender, and others party thereto, and the Trademark Security Agreement dated as of December 4, 2019 by and among the Grantor and Lender (“Trademark Security Agreement”), Grantor granted to Lender a security interest in the Trademark Collateral; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on December 4, 2019 at Reel 6808 Frame 0432.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Lender, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.


SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

SECTION 4. Acknowledgement. The release of security interest granted herein expressly does not include a release of the security interest granted pursuant to the Pledge and Security Agreement dated as of September 16, 2021 (as amended, modified, extended or restated from time to time) by and among the Grantor, Regions Bank, in its capacity as collateral agent thereto, and others party thereto.
