ASSIGNMENT OF TRADEMARKS

For good and valuable consideration paid by the Assignee to the Assignor, the receipt and sufficiency whereof Assignor hereby acknowledges, Assignor does hereby transfer, convey and assign unto Assignee all right, title and interest in and to the Marks throughout the world, together with the goodwill of the business symbolized by the Marks, all registrations and applications for registration of the Marks, including without limitation those identified on the attached Schedule A, and also all past, present and future rights of enforcement, including all rights to sue for infringement or unauthorized use, of the Marks, whether known or unknown, now existing or hereafter arising.
