THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (the "Release") is made as of September 20, 2021, by PRAESIDIAN CAPITAL BRIDGE FUND LP, a Delaware limited partnership, as Agent ("Lender"), in favor of REMEDY HEALTH GROUP, LLC, a Delaware limited liability company ("Borrower").

#### RECITALS

WHEREAS, pursuant to that certain Subordinated Intellectual Property Security Agreement dated November 18, 2020, by and among Borrower and Lender (the "Security Agreement"), recorded on November 18, 2020, at Reel 7109, Frame 0681, United States Patent and Trademark Office, Borrower granted a security interest in certain intellectual property in favor of Lender to secure certain debt owing from Borrower to Lender;

WHEREAS, Borrower has requested that Lender (i) terminate and release the liens and interests of Lender in certain of Borrower's intellectual property as set forth in Exhibit A attached hereto (the "Intellectual Property"), and (ii) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office and other appropriate offices; and

WHEREAS, Lender has agreed to such release and termination.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby releases and terminates its security interests in the Intellectual Property, and reassigns to Borrower all right, title and interest of Lender in and to the Intellectual Property.
