THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (the "Release") is made as of September 20, 2021, by PRAESIDIAN CAPITAL BRIDGE FUND LP, a Delaware limited partnership, as Agent ("Lender"), in favor of REMEDY HEALTH GROUP, LLC, a Delaware limited liability company, RHGH, LLC, a Delaware limited liability company, and REMEDY HEALTH ASSOCIATES, LLC, a Delaware limited liability company (collectively the "Borrower").

WITNESSETH:

WHEREAS, pursuant to that certain Subordinated Intellectual Property Security Agreement dated November 10, 2017, by and among Borrower and Lender (the "Security Agreement"), recorded on December 4, 2017, at Reel 6219, Frame 0484, United States Patent and Trademark Office, and recorded on December 21, 2017, Document No. V9952D761, U.S. Copyright Office, Borrower granted a security interest in certain intellectual property in favor of Lender to secure certain debt owing from Borrower to Lender;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby releases and terminates its security interests in the Intellectual Property, and reassigns to Borrower all right, title and interest of Lender in and to the Intellectual Property.






