**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT
(TRADEMARKS)**

This Release of Intellectual Property Security Agreement (Trademarks) is entered into as of September 20, 2021 by PNC Bank, National Association (“PNC”), as agent for Lenders (“Releasor”), to REMEDY HEALTH GROUP, LLC, a Delaware limited liability company (“Remedy Health”), RHGH, LLC, a Delaware limited liability company (“RHGH”) and REMEDY HEALTH ASSOCIATES, LLC, a Delaware limited liability company (“RHA”, and together with Remedy Health and RHGH, each, a “Releasee” and, collectively, the “Releasees”).

W I T N E S S E T H:

REFERENCE is made to that certain Revolving Credit, Term Loan and Security Agreement, dated as of November 10, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Loan Agreement”) by and among the Releasees, the financial institutions which are now or which hereafter become a party thereto as lenders and PNC, as agent for Lenders;

WHEREAS, pursuant to that certain (a) Intellectual Property Security Agreement, dated as of November 10, 2017 (the “First IP Security Agreement”), by the Releasees in favor of the Releasor, and recorded by the United States Patent and Trademark Office (“USPTO”) on November 14, 2017 under Reel/Frame 6204/0385 and (b) Intellectual Property Security Agreement, dated as of November 24, 2020 (the “Second IP Security Agreement”, together with the First IP Security Agreement, collectively the “IP Security Agreements”), by Remedy Health in favor of the Releasor, and recorded by the USPTO on November 24, 2020 under Reel/Frame 7114/0338, the Releasees, to secure the payment or performance, as the case may be, in full of the Obligations (as defined in the Loan Agreement) of each Releasee, granted to Releasor a security interest in the Intellectual Property Collateral as defined therein, including those Trademarks, listed on Schedule A hereto (collectively, the “Trademark Collateral”); and

WHEREAS, each Releasee has requested, and Releasor has agreed to execute, acknowledge and deliver, this Release of Intellectual Property Security Agreement (Trademarks) in order to terminate the IP Security Agreements and confirm the release, relinquishment and discharge of its continuing security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, including the satisfactory performance and payment in full of all the Obligations of each Releasee, the sufficiency and receipt of which are hereby acknowledged, Releasor hereby agrees as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, capitalized terms used herein shall have the meanings given to them in the IP Security Agreements.

SECTION 2. Release of Security Interest. Releasor hereby, without any representation or warranty and without any recourse to Releasor, terminates the IP Security Agreements and hereby terminates, releases, relinquishes and discharges its lien on and security interest in the Trademark Collateral and, to the extent applicable, re-assigns and re-conveys to each Releasee any and all right, title and interest Releasor may have in or to the Trademark Collateral.

SECTION 3. Governing Law. THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (TRADEMARKS) SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAW OF THE STATE OF NEW YORK.
