## TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this “Termination and Release”) is granted as of September 1, 2021 by CITIZENS BANK, N.A. as agent for its own benefit and the benefit of the other Secured Parties (f/k/a CITIZENS BUSINESS CAPITAL, the “Agent”), in favor of PRO CORPORATION, a Delaware corporation, PRO UNLIMITED GLOBAL SOLUTIONS, INC, a Delaware corporation and PRO UNLIMITED, INC., a Delaware corporation (collectively, the “Grantor”).

**WHEREAS**, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of May 1, 2017 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**2017 Grant**”), granting the Agent a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office (“**USPTO**”) on May 2, 2017, at Reel 6046, Frame 0621;

**WHEREAS**, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of March 29, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**2019 Grant**”), granting the Agent a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded in the USPTO on March 29, 2019, at Reel 6604, Frame 0290;

**WHEREAS**, the Grantor executed and delivered a First Amendment to Intellectual Property Security Agreement dated as of February 3, 2021 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**2021 Grant**”), granting the Agent a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded in the USPTO on February 4, 2021, at Reel 7180, Frame 0821;

**WHEREAS**, the Grantor has requested that the Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the trademarks and trademark applications described in the 2017 Grant, the 2019 Grant and the 2021 Grant (collectively, the “**Trademarks**”) as herein provided; and

**WHEREAS**, the Grantor has requested that the Agent provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Trademarks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under (i) the Trademarks, including without limitation those trademarks and trademark applications identified in Exhibit A hereto, (ii) all proceeds and products of the Trademarks, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof


for infringement of any of the Trademarks or unfair competition regarding the same; and assigns, transfers and conveys to Grantor any interest in all of the foregoing, including any lien and security interest thereof; and

2. authorizes and requests that this Termination and Release be recorded with the USPTO.
