## PATENT, TRADEMARK AND LICENSE SECURITY AGREEMENT

THIS PATENT, TRADEMARK AND LICENSE SECURITY AGREEMENT (this "Agreement") made as of this 2nd day of September, 2021 by and between GENEVA SUPPLY, INC., a Wisconsin corporation, PRESTIGE PAINTS LLC, a Wisconsin limited liability company, INTERSTATE MUSIC LLC, a Wisconsin limited liability company (individually, each a "Grantor" and collectively, the "Grantors"), in favor of FIRST MIDWEST BANK, as administrative agent for the Lenders party to the Loan Agreement (as hereinafter defined) (in such capacity, together with its successors, the "Administrative Agent");

### WITNESSETH:

WHEREAS, Grantors and have entered into a certain Loan and Security Agreement dated as of even date hereof (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement") with various financial institutions and the Administrative Agent, providing for the extensions of credit to be made to the Grantors by the Lenders; and

WHEREAS, pursuant to the terms of the Loan Agreement, Grantors have granted to Administrative Agent, for the benefit of Administrative Agent and the Lenders, a security interest in substantially all of the assets of each Grantor, including all right, title and interest of each Grantor in, to and under all now owned and hereafter acquired patents, trademarks, patent and trademark applications and patent and trademark licenses, and all products and proceeds thereof (but subject to the terms of the Loan Agreement), to secure the payment of all amounts owing by such Grantor under the Loan Agreement.

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Grantors agree as follows:

1. Incorporation of Loan Agreement. The Loan Agreement and the terms and provisions thereof are hereby incorporated herein in their entirety by this reference thereto. All terms capitalized but not otherwise defined herein shall have the same meanings herein as in the Loan Agreement. In the event that any provision of this Agreement is deemed to conflict with the Loan Agreement, the provisions of the Loan Agreement shall control.

2. Grant and Reaffirmation of Grant of Security Interests. To secure the payment and performance of the Obligations, each Grantor hereby grants to Administrative Agent, for its benefit and the benefit of Lenders, a continuing security interest in such Grantor's entire right, title and interest in and to the following, whether now owned or existing or hereafter created, acquired or arising (for the avoidance of doubt, excluding, in each case, such items as are not included as "Collateral" pursuant to the terms and conditions of the Loan Agreement):

(i) patents and patent applications, including, without limitation, the inventions and improvements described and claimed therein, and those patents and patent applications listed on Schedule I attached hereto and made a part hereof, and (a) the reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, (b) all income,

royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including, without limitation, damages and payments for past or future infringements thereof, (c) the right to sue for past, present and future infringements thereof, and (d) all rights corresponding thereto throughout the world (all of the foregoing patents and applications, together with the items described in clauses (a) through (d), inclusive, in which each Grantor now or hereafter has any right, title or interest are sometimes hereinafter individually and/or collectively referred to as the "Patents");

(ii) each trademark and trademark application owned by any Grantor, including, without limitation, each trademark and trademark application referred to in Schedule 2 annexed hereto, together with any reissues, continuations or extensions thereof and all goodwill associated therewith; provided, that notwithstanding the foregoing, no grant of any security interest shall be deemed granted hereunder on or in any "intent to use" trademark application for which a statement of use has not been filed and accepted with the U.S. Patent and Trademark Office;

(iii) all Grantors' rights and obligations pursuant to its license agreements listed on Schedule 3 with any other Person or Persons with respect to any Patents and Trademark, whether each Grantor is a licensor or licensee under any such license agreements, and, subject to the terms of such licenses, the right to prepare for sale, sell and advertise for sale, all Inventory now or hereafter owned by any Grantor and now or hereafter covered by such licenses (all of the foregoing is hereinafter referred to collectively as the "License Agreements"); and

(iv) all products and proceeds of the foregoing, including, without limitation, any claim by any Grantor against third parties for past, present or future infringement of any such patent and trademark, including, without limitation, any patent and trademark referred to in the schedules annexed hereto, any patent and trademark issued pursuant to a patent and trademark application referred to in the schedules hereto and any patent and trademark licensed under any patent and trademark license.


