## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of September 17, 2021 (this "Release") is made by CITIZENS BANK, N.A., as collateral agent (in such capacity, together with its successors and permitted assigns, the "Collateral Agent") for the Secured Parties (as defined in the Security Agreement referred to below) in favor of PLAYNETWORK, INC., a Washington corporation (the "Grantor").

1.

Pursuant to that certain Security Agreement Supplement No. 1 dated as of May 12, 2017 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement Supplement"), pursuant to which such Grantor became a party to that certain Security Agreement, dated as of May 31, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), the Grantor and Collateral Agent entered into a certain Trademark Security Agreement (First Lien), dated as of May 12, 2017 and recorded in the United States Patent and Trademark Office on May 12, 2017, at Reel 6058, Frame 0082 (the "Trademark Security Agreement"), and pursuant to the Security Agreement and Trademark Security Agreement, the Grantor granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including the foregoing identified on Schedule A hereto and incorporated herein by reference.

2.

The Collateral Agent, without representation, warranty or recourse of any sort, hereby terminates, releases and discharges the grant of and all of its lien on and security interest in, all right, title and interest in, to and under the Trademark Collateral granted under the Trademark Security Agreement, including the foregoing identified on Schedule A hereto and incorporated herein by reference and hereby terminates and cancels the Trademark Security Agreement. Any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby cease and become void. This Release does not terminate, release or discharge the Collateral Agent's security interest in any intellectual property or any other asset of the Grantor other than the Trademark Collateral.

3.

The Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary and requested by the Grantor to effect the release of the security interest contemplated hereby, at the Grantor's expense. The Collateral Agent hereby authorizes the Grantor or the Grantor's authorized representative to record this Release with the United States Patent and Trademark Office.

4.

This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery by telecopier or by electronic .pdf copy of an executed counterpart of a signature page to this Release shall be effective as delivery of an original executed counterpart of this Release.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
