RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of September 21, 2021 (this "Release"), is made by BNP PARIBAS, in its capacity as Administrative Agent for the Lender Parties (together with its successors and permitted assigns, in such capacity, the "Administrative Agent") in favor of WHISPS ACQUISITION CORP., a Delaware corporation (the "Grantor"). Capitalized terms used but not defined herein having the meanings assigned to them in the Pledge and Security Agreement.

WITNESSETH

WHEREAS, Grantor and Administrative Agent are parties to that certain Pledge and Security Agreement dated as of April 18, 2019 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Pledge and Security Agreement");

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantor executed the Trademark Security Agreement, dated as of April 18, 2019 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on April 19, 2019 at Reel/Frame No. 6624/0239, pursuant to which the Grantor pledged and granted to the Administrative Agent for the benefit of the Lender Parties a continuing security interest in all of Grantor's right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement).


WHEREAS, the Grantor has requested that the Administrative Agent release its security interest in all right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademark Collateral under the Pledge and Security Agreement and the Trademark Security Agreement.


